New Kyoto Prefecture *MICE subsidies have been started for the 2016 fiscal year!

*MICE: Meetings, Incentive, Convention, Exhibition/Event

Meetings held in Kyoto Prefecture will now be eligible for financial support.



Convention Subsidy

Up to JPY 500,000 of support available for conventions

Eligibility Requirements

Must be used for expenses involved in holding a convention

Convention must be held within Kyoto Prefecture, but outside of Kyoto City

Meeting must be at least 2 days long and have at least 50 participants

Participants must be from at least 3 different countries

Can be used in conjunction with the other Kyoto Prefecture MICE subsidies

Subsidy Award Limits

50 - 199 participants: JPY 200,000 200 participants or more: JPY 500,000

Organizers, operators, administrative staff, etc. of international meetings (scholarly meetings/congresses, etc.)

At least 1 month in advance in the fiscal year when the meeting will be held



Breakout Session Subsidy

Up to JPY 200,000 of support for meetings with breakout sessions in Kyoto Prefecture

Eligibility Requirements

Must be used for expenses involved in holding one or more breakout sessions

Breakout sessions must be held within Kyoto Prefecture, but outside of Kyoto

The main convention (that the breakout session is part of) must be at least 2 days long, have participants from at least 3 different countries, and be held in the Kinki area prefectures. (Kyoto, Osaka, Shiga, Hyogo, Nara, or Wakayama)

Can be used in conjunction with the other Kyoto Prefecture MICE subsidies

15 - 99 participants: JPY 100,000 100 participants or more: JPY 200,000

Organizers, operators, administrative staff, etc. of international meetings (scholarly meetings/congresses, etc.)

At least 1 month in advance in the fiscal year when the meeting will be held



Excursion Subsidy

Up to JPY 200,000 of support for holding tours

Eligibility Requirements

Must be used for expenses involved in holding a tour/excursion in conjunction with a convention

Tour must include at least one stop at a temple, facility, etc. in Kyoto Prefecture but outside of Kyoto City limits

The main convention that the excursion is part of must be held within Kyoto Prefecture (including Kyoto City), be at least 2 days long, and include participants from at least 3 different countries

Can be used in conjunction with the other Kyoto Prefecture MICE subsidies

Subsidy Award Limits

15 or more participants: JPY 200,000

Organizers, operators, administrative staff, etc. of international meetings (scholarly meetings/congresses, etc.)

At least 1 month in advance in the fiscal year when the meeting will be held
